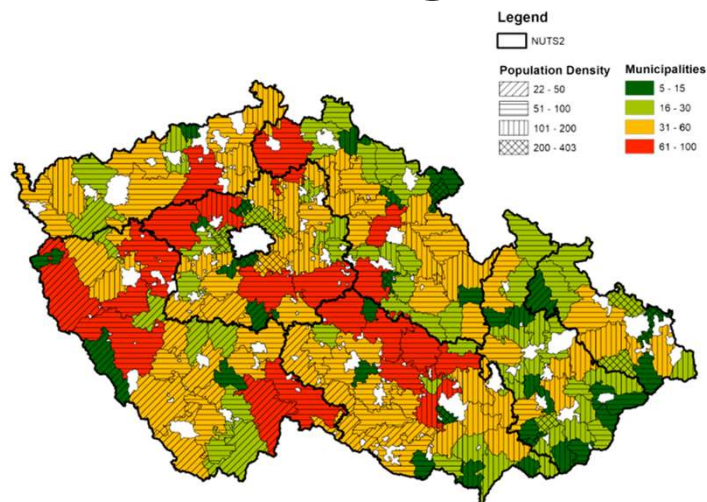

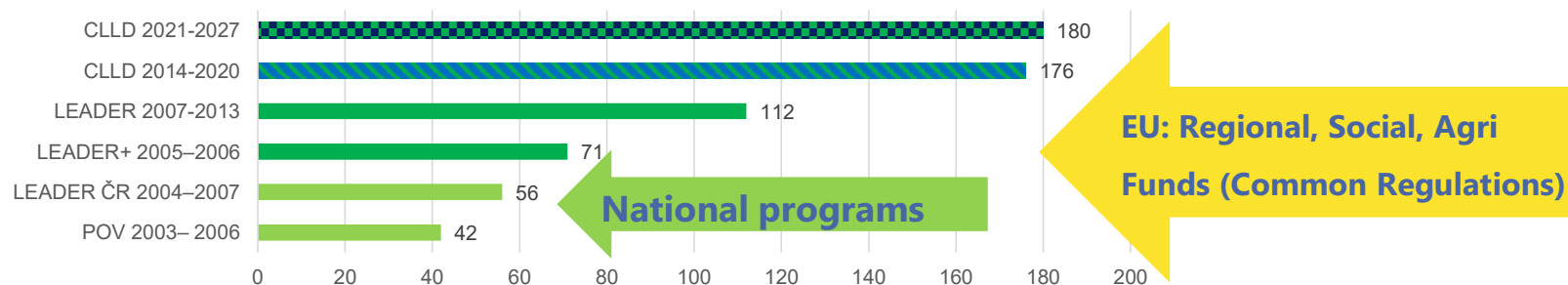

- Standardization, SCLLD approval, MPIN (methodological guidelines)

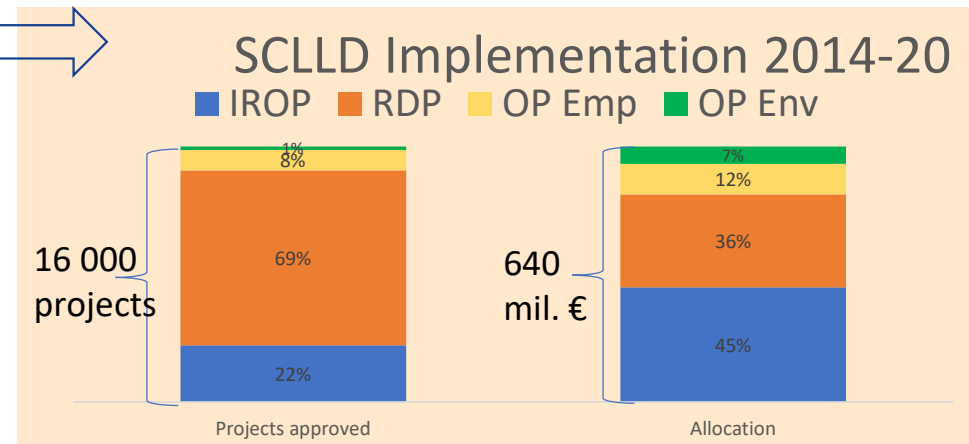
## Supported LAGs



# Multifond CLLD in Czechia

- 2014-2020

- 3 Funds (EAFRD, ERDF, ESF), 4 OPs (3 investments, 1 non-investment)
- Eligibility conditions set by each OP
- Twice a year summit of ministries and regional/territorial/ local partners
- CLLD: On monthly basis meetings on working level (ministries plus National Network of LAGs)



- 2021-2027

- Not much change in the main settings
- New programme involved (OP Tech)
- No Leadfund (new programme for financing LAGs involved OP TA)
- Changes in requirements for LAGs strategies (simplification, separate approval of Programme Frames)

# ERDF CLLD: OP IROP

- Areas for support in LAGs
  - Transport (cyclists, infrastructure for pedestrians )
  - Integrated Rescue System (equipment and stations for the emergency services)
  - Social integration (deinstitutionalisation, social housing, social services)
  - Social Entrepreneurship
  - Education (nursery, primary and secondary schools, life long learning)
  - Cultural heritage (monuments, museums and libraries)
  - Territorial development (territorial development documents)
  - Provision of preparatory support, operational and animation activities of LAGs involved in the implementation of CLLD projects
  
- The most effective project: transport, education and social infrastructure

# CLLD in our OPs

## **WHAT WE BUILT ON: LAGs - Animation of rural areas**

- knowledge of the local needs/resources, strategic planning, trust based on long term cooperation, flexibility, tailoring to the needs, innovatory approach, communication with the territory and preparation of documentation with territorial partners and between them

## **WHAT IS OUR APPROACH: Where there's a will, there's a way**

- ownership of CLLD operations within separate OPs, regular working meetings, capacity building and open dialogue
- IROP - allocation for the operation and animation of the LAG moved to the technical assistance programme, distribution of only 70% of the reserved allocation for LAGs, separate priority axis for CLLD

## **WHAT WE FOCUS ON NOW AND NEAR FUTURE: Capacity building of LAGs**

- EMPL+ - monitoring and special indicators on target groups' progress, self-evaluation of LAGs – conditional for the following project, thematic seminars, consultations, international conference next year - ?

## **WHAT WE PLAN TO INNOVATE: Pilot on urban-CLLD**

- initial/preparatory phase, kick-off 2024 - ?
